

A Royal Affair

ABHA Sale Rules

It is the goal of this elite sale to present the best cattle that the ABHA membership has to offer to the buying public. There will be a screening/selection process to ensure the quality of the Sale entries. With that goal in mind, the ABHA Show Committee has adopted the following rules:

1. A photo of the animal's Registration Certificate, a copy of the footnotes, and a photo and brief video (10-20 seconds) of the nominated animal(s), must be submitted to screening@blackhereford.org as soon as possible, and no later than the 10th of July, 2020. This is for the selection process only, and not the catalog. Consignors will be notified within one week of the acceptance or denial of their nominated animal(s).
2. All nominated cattle must be registered with the ABHA, and have a permanent tattoo number in one or both ears that corresponds to the permanent ID number listed on the animal's registration certificate.
3. Once accepted, all Registration/Sale Entry Forms should be completed immediately, and payment made in full. DEADLINE FOR ENTRY AND PAYMENT IS AUGUST 1, 2020. This can be done on the ABHA Website, or emailed to the ABHA office at beverly@blackhereford.org, and credit card payment completed by phone with Beverly Chafon at the ABHA office. (833-501-4750). 4. All accepted cattle must have a high resolution, j-peg format photo to be used in the catalog. A 10 to 20 professional quality video is also required. The deadline for catalog photos, and the videos, is August 1, 2020.
5. It is required that all cattle consigned to the "A Royal Affair" sale MUST be entered and exhibited in the American Royal ABHA Show. It is further required that consignors exhibit that animal for the new owner in the ABHA Show on October 16, 2020 unless the new owner requests to show the animal themselves.

Show entries are to be made directly to The American Royal. The American Royal will not release any cattle until the ABHA show has ended.

6.. The non-refundable "A Royal Affair" consignment fee is \$200 per live consignment (this includes "pick" consignments), and \$100 per embryo package or right to flush consignment.

7. A 14% consignment fee will be assessed by the ABHA on the purchase price of all lots. Floored animals that do not sell will be required to pay the 14% commission based on the last bid taken by the Auctioneer.

8. It is understood that by consigning in "A Royal Affair", the consignor is entering into a contract to sell that animal. Cattle are to be withdrawn from the sale for medical reasons ONLY, to be verified by signed Veterinary letter. Consignors who withdraw cattle for any other reason risk exclusion from future ABHA sales.

9. All bulls consigned must meet the following requirements: A. A birth date of November 1, 2019 or BEFORE. B. Be an ABHA Approved Herd Sire. C. The ABHA is setting a mandatory floor of \$3,000 on any bull consigned. D. Bulls are limited to one (1) per consignor. E. Bulls must be accompanied by a Breeding Soundness Exam, and a negative Trich test, signed by a licensed Veterinarian. F. Bull consignments will be limited. G. Bulls that do not reach the \$3,00 floor and do not sell will only forfeit the \$200 entry. They will be charged the 14% commission only if they sell.

10. All Open Heifers must be weaned and vaccinated 45 days prior to October 15, 2020.

11. All bred Heifers must be confirmed pregnant by a licensed Veterinarian 30 days prior to sale.

12. All consigned cattle must have an individual 30 day Health Certificate that meets the requirements of the State of Missouri, which include a metal ID Tag , or E.I.D. tag, with the ID number reflected on that animal's Health Certificate.

13. Cattle will be allowed to enter the grounds of the American Royal at 7 a.m. central time on Wednesday, October 14, 2020, with deadline for arrival to be 6 p.m. central time on the 14th. Cattle will be checked in by an ABHA representative. Bedding will be provided by The American Royal.

14. Please note that altering the conformation or appearance of an animal is not allowed. This includes covering white skin, and false hair of any kind, with the exception of tail switches. Graphite, powders, hemp, or other substances used externally are also prohibited, as are steroids, illegal pharmaceuticals, or artificial filling.

15. If the rules of the sale are not met, the ABHA reserves the right to disqualify any entry.

16. All cattle MUST BE PAID FOR before being loaded. A paid receipt will be provided to all buyers to be presented at loading. Buyers on <http://www.LiveAuctions.TV> will be responsible for making arrangements for payment immediately following the conclusion of the Sale.
